**RE: Hurricane Ian Recovery; Emergency Actions to Ensure Voting Access**

Dear Secretary Byrd, Director Matthews, and Mr. McVay,

The Florida State Conference of the NAACP, All Voting is Local Florida, Common Cause Florida, Equal Ground, ACLU of Florida, Campaign Legal Center, Demos, LatinoJustice PRLDEF, and the Lawyers' Committee for Civil Rights Under Law write to express our concern about the impact of Hurricane Ian on Floridians' ability to successfully vote in the ongoing general election. The destruction caused by Hurricane Ian has significantly disrupted election administration in affected counties,<sup>1</sup> as well as United States Postal Service ("USPS") operations,<sup>2</sup> and has displaced thousands of Floridians to locales across the state who must now attempt to identify alternative means of voting while they remain unable to return to their homes and struggle to meet basic needs.

Recognizing this, we respectfully request that the Department of State (“DOS”) take the following emergency actions to ensure voting access for all Floridians, in light of the continuing effects of this devastating natural disaster. Pursuant to Section 4 of Executive Order 22-218, issued September 23, 2022, as amended by Executive Order 22-219, issued September 24, 2022, state agencies currently have the authority to “suspend the provisions of any regulatory statute, order, or rule, if strict compliance with the provisions of the statute, order, or rule would prevent, hinder, or delay necessary action in coping with the emergency.”<sup>3</sup> Each of the actions outlined below are necessary to cope with the ongoing emergency by ensuring voting access for affected Floridians,<sup>4</sup> and thus within the authority of DOS under existing Executive Orders. To the extent that you believe a new Executive Order is needed to provide additional authority to undertake any of these actions, we request that the Governor issue such an order.

### 1. Voter Registration

- a. Extend the Voter Registration Deadline statewide from October 11 to October 18;
- b. Allow completed voter registration forms to be submitted to any SOE office statewide, not just to the office in the county where the registrant resides;

### 2. Early Voting

- a. Extend the mandatory Early Voting period in affected counties<sup>5</sup> from October 29 through November 5 to October 24 through November 7, or, in the alternative, allow SOEs in affected counties to conduct early voting every day beginning October 24 through November 7;<sup>6</sup>
- b. Extend the mandatory Early Voting hours in affected counties from 8 hours to 12 hours per day throughout the Early Voting period;
- c. Allow SOEs in affected counties to designate additional Early Voting Sites, provided that Early Voting sites are geographically located so as to provide all voters in the county an equal opportunity to cast a ballot;<sup>7</sup>

### 3. Vote-By-Mail

- a. Allow SOEs in affected counties to accept written (including email) or telephonic requests for a VBM ballot to be mailed to an address other than the voter’s address on file;<sup>8</sup>
- b. Allow SOEs to send VBM ballots via forwardable mail such that displaced voters who have provided a forwarding address to USPS do not need to request a new ballot, and work with USPS officials to ensure VBM ballots are forwarded;<sup>9</sup>
- c. Allow SOEs to offer voters the opportunity to cast ballots, including VBM ballots, directly at supervised emergency shelters housing voters displaced from their homes, and at other supervised or assisted living centers and nursing homes in affected counties;
- d. Allow SOEs in affected counties to expand their use of Secure Ballot Intake Stations (“SBINS”), both in quantity and location;
- e. Provide for expanded use of mobile SBINS in affected counties, provided that mobile SBINS are geographically disbursed so as to provide all voters in the county an equal opportunity to cast a ballot;

#### 4. Polling Locations

- a. Allow SOEs in affected counties to relocate or consolidate polling locations, including Early Voting locations, provided that polling locations are geographically located so as to provide all voters in the county an equal opportunity to cast a ballot, and that SOEs consult with community members about the final location of polling places;<sup>10</sup> and
- b. Allow voters in affected counties to cast their ballot at any polling location within the county, or in the alternative, allow SOEs in affected counties to create polling locations at which any voter in the county can cast their ballot (“vote centers”), provided that vote centers are geographically located so as to provide all voters in the county an equal opportunity to cast a ballot, and that SOEs consult with community members about the final location of vote centers.<sup>11</sup>

We further request that you update the website for the Division of Emergency Management<sup>12</sup> with any changes to any voting procedures through Election Day, November 8, and the close of the canvassing period. We further request that you provide a prominent link to that website on the websites for the Division of Elections,<sup>13</sup> the Department of State's Contact Your Supervisors of Elections website,<sup>14</sup> and the individual counties' disaster information and Supervisor of Elections websites. This will allow voters to access up-to-date information about county-level elections infrastructure even where counties lacking power or other resources may not be able to update their individual county websites.

Specifically, we request that you make the following information available on the Division of Emergency Management website, and that this information be updated in real time as changes are made:

1. The days and hours during which individual county Supervisor of Elections' offices will be open and fully functional, including locations and contact information for county Supervisors of Elections in affected counties;
2. The dates, hours, and locations for Early Voting;
3. The dates, hours, and locations for Election Day voting;
4. The dates, hours, and locations for VBM drop-off at SBINS;
5. How to vote in person at Early Voting and vote center locations, including whether displaced voters can vote at these locations if they are outside of their county; and
6. How to vote by VBM ballot for voters in affected counties, including:
  - a. How voters can obtain and cast a VBM ballot if they cannot access their mailing address;
  - b. How voters can obtain and cast a VBM ballot if they have already requested, but cannot locate their VBM ballot; and
  - c. How voters can verify whether a VBM ballot they have already sent back was received, and what to do if it was lost or destroyed.

We appreciate the work you, the SOEs, and others are doing to maintain and restore critical election infrastructure in the face of a serious natural disaster. We stand ready to consult on any aspect of the above and related voter access issues, and assist in providing information to voters through the nonpartisan Election Protection coalition and 866-OUR-VOTE hotline.
